PURSUANT to the prevailing laws and regulations, policies and procedures of India, and both parties have reached the following understanding:



Article 1

OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MOU) is to co-operate each other in educational projects in areas of mutual interest

Article 2

SCOPE OF COOPERATION

Both Parties agree to encourage the following exchange activities based on their respective academic and educational needs.

- i. Exchange of students for appropriate level of study & research
- ii. Exchange of faculty members for teaching, sharing innovative teaching methods and research guidance for the undergraduate students
- iii. Joint Academic Programme development - Skill based certification / add on certification courses
- iv. Collaborative research, cultural and extension programme
- v. Joint Seminar/conferences/Webinars/Symposia and Workshop organization
- vi. Organizing awareness programmes in the field of mutual interest
- vii. Exchange of personnel as Resource person
- viii. Joint research/publication in the field of mutual interest
- ix. Other Academic Exchange Programme as may be agreed to by both the parties from time to time

Article 3

FINANCIAL ARRANGEMENT

Both the colleges will help each other in every aspect of the academic fraternity, but financial commitment under this MOU is subject to the availability of funding sources and approval of the relevant authorities.

Article 4

LOCATION OF ACTIVITIES




MODE OF CONDUCTING THE PROGRAMMES

- 2) Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.




SETTLEMENT OF DISPUTES
