#### 1.0 Objectives:

This memorandum establishes a collaborative partnership between BPC and FGD. It aims to facilitate joint programs related to training, performing and campaigning on *Gambhira* – the folk art form of Malda and Dinajpur. Additionally, the agreement seeks to promote collaborative activities such as the promotion for the folk art and folk artist of the region as may be agreed upon.

#### 2.0 Scope of Collaboration

The parties will collaborate on the following initiatives:

##### 2.1. Workshops and Special Lectures

Both the parties will jointly organize workshops and special training classes on *Gambhira* and other performing art form.

## 2.2. Joint Events and Activities:

The parties will organize joint events for the local community, such as public forums on cultural programs and awareness on folk art forms amongst the students, local community and the persons in the villages adopted by the college.

## 2.3. Content Sharing:


The college will provide the FGD with access to academic research, expert commentary, and other matters relevant to the community and both the parties will maintain copyright and confidentiality of the information shared between them.

## 3.0 General Terms and Conditions:

- 3.1. The agreement is effective from the day of signing by both the parties.
- 3.2. Any modifications to the agreement require mutual approval and signing by both Parties.
- 3.3. Each Party may appoint a nodal officer from their part to oversee collaborative activities.
- 3.4. Volunteers from both Parties can participate in Social Work Activities.
- 3.5. Collaborative activities will occur on the premises of each Party or at an agreed-upon third-party location.
- 3.6. Financial, technical, and academic support decisions must be mutually agreed upon. Both Parties can provide support for various initiatives, including camps, workshops, extension activities, etc.
- 3.7. The agreement will terminate after five years or upon written notice from both Parties.
- 3.8. Extension or renewal of the agreement is possible with mutual consent.

## 4.0 Time Frame:

This collaboration begins on 10<sup>th</sup> Jun, 2026, and lasts for five years. Termination occurs automatically after this period or by mutual agreement. Extension of the agreement is possible upon mutual consent.


